While most of the world has discussed COVID-19 throughout this year, the burning issue within the Canadian Construction Industry continues to be that of **Lien Reform**, **Prompt Payment & Adjudication** – and there has been significant change.

The **PMI-SAC Southern Alberta Chapter** is hosting an Online Panel Discussion Webinar to address the topic.

The Canadian Construction Industry is now undergoing significant change with lien act reform and the introduction of prompt payment and adjudication both provincially and federally. These changes, meant to improve the payment process and provide more efficient handling of construction disputes during the life of a building project, will drive wholesale project management and administrative cultural change to the industry stakeholders.

This session, hosted by PMI-SAC, will provide the history of prompt payment and adjudication in Canada, how it works, and the stakeholder challenges it faces during implementation. The Ontario model, its constraints and risks, will be discussed as it is now provincial law.

This informative three-person moderated panel will provide business executives, project managers and construction industry personnel insight into global trends, and the Canadian developments currently underway, that will have industry-wide commercial and legal implications on a host of payment and dispute resolution issues.

Mr. Glenn Ackerley, of WeirFoulds LLP, Mr. Roy McPhail of Almitra Consulting Inc. and Mr. Paul Winfield of KGC Consulting will address the latest developments from across the construction industry, including a question and answer period at the end of the panel discussion.
