# **KGC Development Growth & Industry Trends**

KGC has witnessed explosive growth in firms seeking assistance in distressed and delayed projects throughout the country over the past nine months. Previously unimaginable global Black Swan events have compromised supply chains and labour staffing resources beyond comprehension.

A resulting growth trend area for the firm has been the emergence of inquiries around conducting due diligence on the current state and commercial health of the project documentation during the execution phase. Driving this phenomenon is an enhanced awareness of the possibility of pursuing or defending against additional contract entitlement due to several months of project delays.

The pattern of more troubled projects combined with well-intended government infrastructure investments will likely exacerbate the problem in the short term.

### **Commercial Management Training**

Staffing continuity challenges to administer and implement prudent Project Contract Administration continue to plague all organizations with no immediate end in sight. # **Adjudication Update**

On February 24th, 2023, ADRIA and its partners (ADRIC & RICS) were formally advised by Service Alberta that the ARCANA (AB) partnership had fully met the Government's requirements and would soon be officially appointed as a Nominating Authority under the PPCLA legislation for Prompt Payment Construction Adjudications in the Province of Alberta.

To promote industry awareness and shore up the transition process, KGC is contributing a \$4,000 Bronze Sponsorship to the Construction Adjudication Prompt Payment Symposium on April 20, 2023, at the Best Western Premier Calgary Plaza Hotel.

The conference's overarching theme will focus on preparing for the transition in Alberta by drawing upon the experience and wisdom of industry professionals from other jurisdictions.
